

Energy Document Portal

The Department of Labor's Energy Document Portal (EDP) is an online system that allows individuals who have filed an EEOICPA claim to electronically submit documents to their case file.

Benefits of Using the Energy Document Portal

- Documents submitted to the EDP are available to claims adjudication staff almost immediately, eliminating time delays.

Information Needed to Upload Documents

To submit documents to the EDP, you will need:

- Division of Energy Employees Occupational Illness Compensation (DEEOIC) Case ID Number
- Claimant's Last Name
- Last 4 Digits of Claimant's Social Security Number

Documents that CAN be uploaded:

- Employment records
- Medical reports
- EEOICPA forms

Documents that CANNOT be uploaded:

- **Form EN-20:** Must be mailed to the jurisdictional DEEOIC district office.
- **New EEOICPA Forms (EE-1, EE-2, EE-3):** Must be mailed to the Central Mail Room or submitted through a DEEOIC Resource Center.

Use of the EDP is voluntary. You can also mail documents to the Central Mail Room or bring them to your DEEOIC Resource Center. Central Mail Room Address: U.S. Department of Labor OWCP/DEEOIC, PO Box 8306, London, KY 40742-8306
